2. The BATANGAS MEDICAL CENTER now invites bids for THE VARIOUS PROJECTS. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”
Bidding is restricted to Filipino citizens/ sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%), interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Batangas Medical Center and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m. Mondays to Fridays.
5. A complete set of Bidding Documents may be acquired by interested bidders from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated at the table above.
It may also be downloaded free of charge from the website of the Procuring Entity provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The Batangas Medical Center will hold a Pre-Bid Conference on January 17, 2020 9:00 a.m. at the BAC Conference Room 2nd Floor OPD Building which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 a.m. on January 29, 2020. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stipulated in ITB Clause 18.

Bid Opening shall be on January 29, 2020 9:00 a.m. at BAC Conference Room 2nd floor OPD Building. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late Bids shall not be accepted.
8. The Batangas Medical Center reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
